The program is open-entry (meaning you can enroll at any time). Individuals who are 16 years or older and have not received their high school diploma or equivalent are eligible for the program. Those under 18 years of age will need to complete an Underage Permission Form prior to official testing

Services Provided:

- Adult Education: this program is for those students who may need additional academic work in reading, writing, and mathematics. This is especially true if someone has been out of school for a very long time. This may eventually lead to preparing for the high school equivalency test (either HISET or GED). Students are given the HISET Practice Test once a month to determine if they are ready for the official high school equivalency test.
- To help us serve you better, an assessment test (GAIN) is administered. From this test, we can determine your reading, writing, and mathematics levels. With the results, we set up individual lesson plans to ensure that you pass the HSE Test.

The Adults Problem Solving Court Programs (Drug Court, Treatment Court, and DWI Drug Court) are designed around the concept of positive reinforcement and based on a team effort for support. The programs recognize and accept that an individual may struggle to remain substance free or compliant, and therefore, sanctions and therapeutic alternatives are built into the programs when such violations occur.

All the programs are designed in such a way that as participants make progress with their substance abuse and mental health issues, they move from a highly supervised treatment program in the earlier phases to less supervision and restrictions before graduating from the program. Advancement is considered an important achievement and is given considerable attention by the team and the Judge who oversees participants' progress.

The treatment components include: intensive outpatient counseling, substance abuse group therapy, individual therapy, life skill training, 12 Steps Alcoholics Anonymous or Narcotic Anonymous meetings, case management services, anger management, parenting skills, social gatherings, and community service. Participants are also required to undergo regular urinalysis screening, meet frequently with their Probation Officer, and appear weekly before the Judge.

Adult Drug Court Program:

The Adult Drug Court Program in San Juan County is an intensive, outpatient treatment program open to felony level drug and alcohol users. The adults served by this program are sentenced to the program as a condition of their probation.

Adult Treatment Court:

The Adult Treatment Court Program in San Juan County is an intensive, outpatient treatment program open to felony and misdemeanor level offenders. The individuals in Adult Treatment Court have been diagnosed with mental health (and oftentimes substance abuse) issues and who could benefit from help with managing their illness, substance abuse, education and treatment. These clients generally would have little success in completing probation if supervised under regular probation supervision. The adults served by this program are sentenced to the program as a condition of their probation.

Adult DWI Court:

The Adult DWI Drug Court Program in San Juan County is an intensive, outpatient treatment program open to misdemeanor level DWI (2nd and 3rd DWI) offenders struggling with alcohol abuse. The adults served by this program are sentenced to the 28-day inpatient treatment center prior to entering the intensive outpatient portion of the program.

Pretrial Services:

Pretrial Services is not considered a Problem Solving Court. The Pretrial Services Program provides a resource not only to the District and Magistrate Courts, but also to the criminal justice agencies, and citizens of the community because it limits incarceration days for those defendants who can be released to the community thereby reducing incarceration costs.

Pretrial Services provides objective, accurate information to the court through the means of a validated risk assessment and criminal history report to assist the court in making pretrial release decisions. In addition, Pretrial also provides supervision for those defendants released to pretrial based on their risk level. For example, lower risk defendants should be released with minimal conditions, if any. Higher risk defendants who are not detained should be released with conditions that mitigate their identified risk.

The Goals and Objectives of the Eleventh Judicial District Court's Pretrial Services Program is to maximize defendant release rates at the earliest possible time after arrest while minimizing failure to appear and danger to the community. This is achieved through a continuous screening process and the supervision options made available to the courts.

Juvenile Drug Court Program (Including the Wellness Track): The Juvenile Drug Program in San Juan County is an intensive, outpatient treatment program is open to drug and alcohol users, as well as seriously mentally ill juveniles. The juveniles served by this program may be adjudicated or on conditions of release. Juveniles are referred to the Program by one or more of the following agencies: The Court, Juvenile Probation, the District Attorney, or the juvenile's Defense Attorney. The Juvenile Drug Court Program started the Wellness Track in 2016 to address the increase in seriously mentally ill juveniles being referred to the Juvenile Probation Office. The Wellness Track is part of the Drug Court program, but is designed to address the mental health needs of those juveniles identified and accepted into the program.

The program is designed around the concept of positive reinforcement and is based on a team effort for support. It recognizes and accepts that a juvenile may struggle to remain substance free or compliant, and therefore, sanctions and therapeutic alternatives are built into the program when such violations occur. The design concept of the Juvenile Drug Court Program also maintains that individuals continue through the phases of the Program until they successfully graduate.

The program is designed in such a way that as participants make progress with their substance abuse issues, they move from a highly supervised treatment program in the earlier phases to less supervision and restrictions before graduating from the program. Advancement is considered an important achievement and is given considerable attention by the Operational Team and the District Court Judge who oversees participants' progress.

Grade Court:

The Juvenile Grade Court Program is an educational, court monitored problem-solving court designed for Juveniles who are under Court Supervision and have struggles in school and/or have received any grade below a "C" on their report card. The purpose of Grade Court is to encourage the youth to attend school daily, maintain appropriate behavior in school, complete all assigned school work and by doing this the youth will realize the importance of their education. The Grade Court Probation Officer works closely with the

youth, parents and school personnel to ensure that the youth's educational needs are being met, not only through monthly meetings with all parties, but also by attending school meetings and advocating on the youth's behalf if needed. Grade Court recognizes the importance of the parent's involvement in the youth's education; therefore, all parents/guardians are made party respondents. If a parent/guardian refuses to help or participate in the program, they may be sanctioned by the court.

The participant is required to complete a weekly progress report at the end of the week that reflects the participant's current grade as well as the participant's behavior and progress in class. The progress report is signed off by the teachers, student and parent and turned in each week to the Grade Court Probation Officer. The officer then provides a report to the Judge each month when the participant and parent appear before the court. If the youth fails to turn in the paperwork, has unexcused absences, or is refusing to turn in work, they will be subject to sanctions by the court.

The program is designed in such a way that as the youth improves their grades, school attendance and study habits, they receive incentives for their positive behavior, but also gain freedom, through later curfews, and eventually graduation from the program. When juveniles graduate from the program they are provided a certificate that will allow them the benefits of a partial scholarship to the local community college once they graduate from High School or obtain their GED.

Our funders require the Law Center to set priorities to determine the cases that we will accept.

Types of Services-

- **Information & Referral:** Law Center staff tell callers about their legal rights and suggest ways they can resolve their problems. We also tell people how they can contact other offices and agencies to get services.
- **Legal Representation:** If you have a problem related to your disability that falls within our priorities, a Law Center attorney or advocate may accept your case for representation.
- **Systems Advocacy:** The Law Center works to protect the rights of people with disabilities and to increase or improve available services. Our efforts often change laws, regulations, policies and practices. These changes can empower individuals with disabilities to be more independent and productive, and enable them to be included in their community and the workforce.

- Self-Advocacy Training and Education: The Law Center provides training and education about the legal rights of people with disabilities. The audience for our training includes individuals with disabilities, their family members and service providers.

Examples of problems the Law Center can help with:

The Law Center helps Native Americans with disabilities to solve disability-related problems. If you have a disability and qualify for services, the Law Center can help you with problems like:

- Rights to basic support, personal care, therapy and health care – like Supplemental Security Income (SSI), In-Home Supportive Services, Medicare and Medicaid.
- Discrimination in housing, transportation, employment, and access to public and private programs and services.
- Abuse, neglect, and rights violations in a nursing home or other institution.
- Dignity, privacy, choice, and other basic rights.
- Special education rights.
- Mental health and support services.
- Services that Promote independence – such as supported living and family supports.
- Access to technology – like communication devices and power wheelchairs.

If we can't help you ourselves, we can try to refer you to other sources of help.

Meets the needs of Navajo children with delays or disabilities from birth to five years of age with honoring the unique culture and language of the Navajo people. Provides vocational rehabilitation services to eligible American Indians with disabilities who are interested in going to work. Who is eligible for Vocational Rehabilitation Services?

Enrolled member of an Indian Tribe; Reside on or *near the reservation.

Have a Physical or mental impairment which constitutes or results in a substantial impediment to employment. Require vocational rehabilitation services in terms of an employment outcome.

What Services may be provided?

Vocational Rehabilitation services are designed to achieve an employment objective consistent with the unique strengths, resources, priorities, concerns, abilities and capabilities of the individual. The following are the types of vocational rehabilitation services for which an individual with a disability may qualify:

- An assessment for determining eligibility and vocational need.
- Counseling, guidance and work-related placement services.
- Mental/Physical Restoration.
- Maintenance for additional cost incurred while participating in rehabilitation.
- Tuition, books/supplies, personal needs, allowances, room and/or board, transportation.
- Interpreter services for individuals who are deaf and services for those who are blind or visually impaired.
- Occupational licenses, tools, equipment, initial stocks, and supplies. Recruitment and Training Services
- Rehabilitation Technology Services
- Independent Living Services
- Native Healing Services
- Information and Referral

Consumer Participation:

The applicant will be assigned a vocational rehabilitation counselor who will provide counseling and guidance, rehabilitation planning on type of services and the necessary support you might need to reach your job goal.

Once eligibility is determined, an Individual Plan for Employment (IPE) will be developed that will outline the vocational rehabilitation services. When the IPE is agreed upon by both the consumer and Vocational Rehabilitation (VR) Counselor, the plan is reviewed by the supervisor. Once approved by the supervisor the funds are encumbered and approved services are implemented. Upon completion of the IPE, the consumer is expected to find a job and maintain employment. After 90 days of employment, case closure will result based on successful rehabilitation review between consumer and counselor.

The Navajo Nation believes that people with disabilities, when provided the necessary vocational rehabilitation services can return to work and become productive members of our Navajo Society.

How to apply for Vocational Rehabilitation:

Individuals who are interested in going to work and who meet the eligibility criteria are encouraged to apply for vocational rehabilitation services.

Write, telephone or visit the office nearest your home for an appointment.

Individuals will need to complete an application for vocational rehabilitation services. Bring in records or information about your disability. (For example, records from your doctor, psychologist or school.)

An initial intake interview will be conducted with the applicant. An appraisal of the disability and how it affects his/her becoming employed is required to determine eligibility within 60 day. VR services help people with disabilities to manage a job that is consistent with their unique strengths and capabilities.

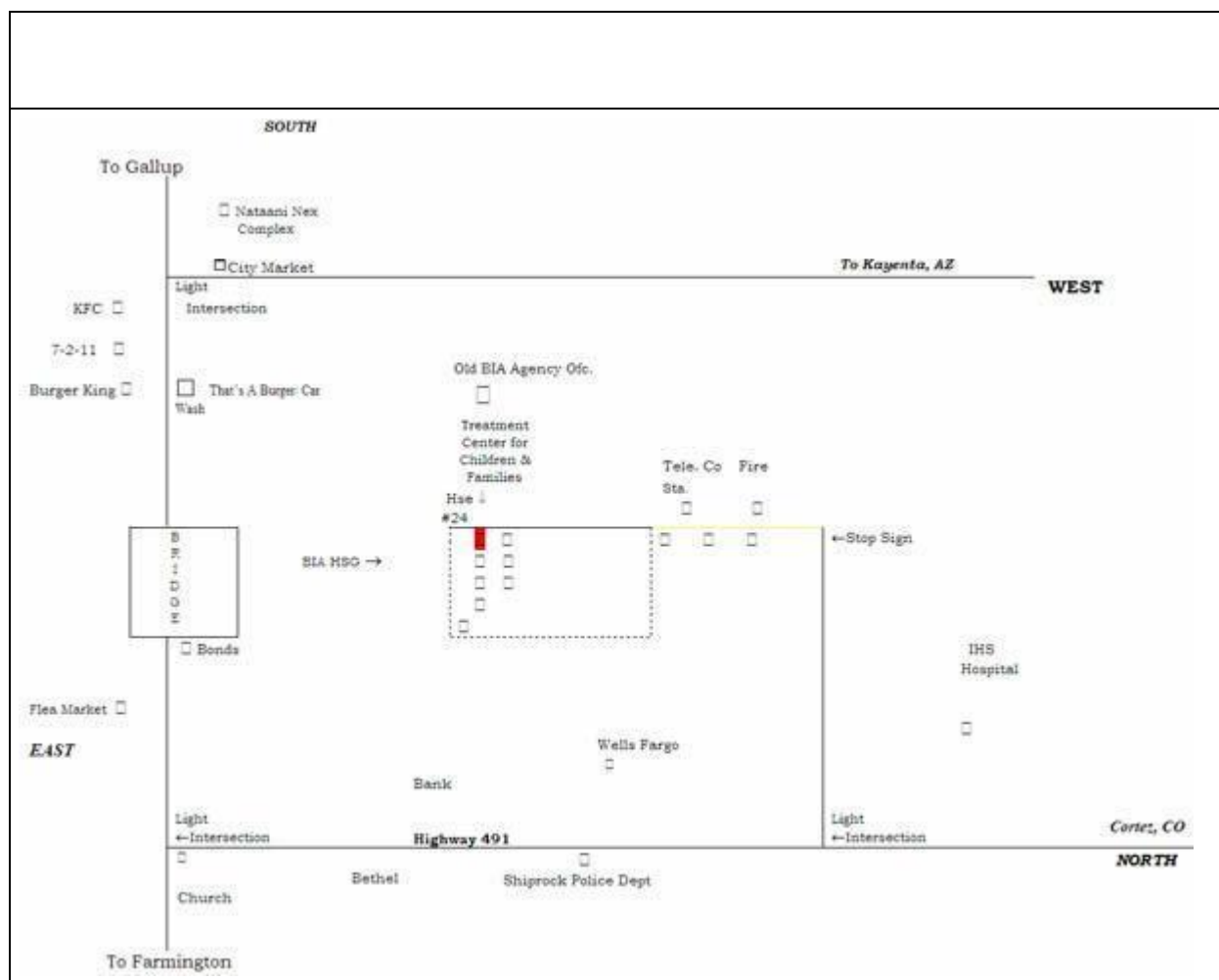

The Northwest New Mexico First Born Program provides first time mothers, fathers, and primary care providers with education and support to encourage normal growth and development of happy, healthy babies in positive nurturing families. Northwest New Mexico First Born builds family and community relationships by supporting the idea that a healthy pregnancy and childhood are not only critical to the immediate well-being of the child but also basic to building a resilient family and healthy community.

Visits take place over the phone or via zoom. Visits are designed to increase knowledge, skills, and insights into the parenting process while guiding families through the child's first three years. San Juan Center for Independence is a community based non-profit agency that was established by people with disabilities for people with disabilities. The Agency serves as a consumer driven community action program that provides services which help maximize independent living choices for all people regardless of the individual's disability.

Primary Services Provided:

- Independent Living Skills: An independent Living Specialist at SJCI is really a generalist who supports people with disabilities toward the independent lifestyle of their choice. What an ILS does: teach by example and role model, refer to current community resources, emotional support - from adaptive recreation to personal crisis. community living. SJCI has Independent Living Specialists who work along with the resident to create a comprehensive plan for transitioning to community living. The transition plan will include locating housing, budgeting, community support systems and home health services.

Youth Transitions: As a community, it is our responsibility to make sure young people with disabilities DO get the same opportunities and support that the rest of us take for granted.
